1. Introduction

These Terms and conditions apply to this website and to the transactions related to our products and services. date the item(s) were indicated as delivered to you or your representative by the tracking information provided on the carrier website or, in the case of locally delivered orders, the date the order was delivered and marked complete.

8.2 Effects of withdrawal - physical goods and products

If you elect to return item(s), we shall reimburse you all payments received from you, including the costs of delivery (with the exception of the supplementary costs resulting from your choice of a type of delivery other than the least expensive type of standard delivery offered by us), without undue delay and in any event not later than 14 days from the day on which we are informed about your decision to withdraw from this contract. We will carry out such reimbursement using the same means of payment as you used for the initial transaction unless you have expressly agreed otherwise; in any event, you will not incur any fees as a result of such reimbursement.

You shall send back the goods or hand them over to us or a person authorised by us to receive the goods, without undue delay and in any event not later than 14 days from the day on which you communicate your desire for return. The deadline is met if you send back the goods before the period of 14 days has expired.

We may withhold reimbursement until we have received the goods back or you have supplied evidence of having sent back the goods, whichever is the earliest.

You will have to bear the direct cost of returning the goods.

You are only liable for any diminished value of the goods resulting from the handling other than what is necessary to establish the nature, characteristics, and functioning of the goods.

Please note that there are some legal exceptions to the right to withdraw, and some items can therefore not be returned or exchanged. We will let you know if this applies in your particular case.

8.3 Products damaged in shipping

Due to the inherent risk in shipping glass products, we are not liable for damages occurred during shipping. We will make every reasonable effort to ensure items are shipped in a manner that results in delivery in the original condition. In the event that you receive your item(s) damaged, we will make every effort to make it right. In the event that an item is received damaged, you must provide us with a photo of the damaged item, the shipping container the item was received in, and the original product receipt. We may elect to a) replace the item at no cost to you, b) repair the item and send it back to you once repaired, you will bear the cost of return shipping, or c) refund the item.

8.4 Refunds on payments for Services or Digital Items

We do not refund payments made for Services or any Digital content, including, but not limited

to, piano tuning services, home automation services, and home network services.

9. Content posted by you
